During the term of the warranty period: parts, assemblies, or components deemed to be defective will be repaired or replaced at our option, free of charge. All costs related to removal, reinstallation and transportation will be paid by the purchaser/customer and/or operator of the product. Evaluation, repair and/or replacement of any defective part(s) are FOB manufacturer's factory.
This warranty does not cover products or parts that are damaged from improper use or abuse, as determined by HindlePower. Accessory items or additional items carry only their respective manufacturer's warranty. Consumable items (such as fuses and electrolytic capacitors), which wear out under normal use are specifically not covered by this standard warranty. Any consequential damage due to diagnosis or repair by any party other than HindlePower authorized personnel is not covered under this warranty.

HindlePower reserves the right to make final determination regarding the application of this warranty. HindlePower will be responsible for costs related to inbound and outbound freight of warranted magnetic components. Freight cost is based on standard UPS rates or common carrier only, as appropriate. Costs related to removal and/or reinstallation of warranted magnetic components will be the responsibility of the purchaser/customer and or operator of the product.
